

**ORANGE COUNTY INTERSCHOLASTIC
ATHLETIC ASSOCIATION
GIRLS BASKETBALL BY-LAWS
Updated August 9, 2017**

1. The current year NCAA Women's Basketball Rules and the NYSPHSAA Handbook will apply.
2. The following OCIAA Rules and Policies will apply:
 - a. The approved OCIAA Basketballs are: "The Rock" Basketball is the preferred ball to use during the regular season; Spalding TF1000 Classic or the Spalding Legacy is also approved for use during the regular season and is mandatory to use starting with the Section IX Tournament.
 - b. The home school must use anti whip nets.
 - c. The home school will provide a minimum of 6 warm-up balls for the visiting team.
 - d. All schools must have a 30 second clock and an alternate possession clock.
 - e. Home school will provide a dressing room for the visiting team.
 - f. Pep bands are permissible at home contests prior to the contest, during alternating cheerleading time-outs and at half time.
 - g. Home team will provide any warm-up music. Spectators are not allowed to bring radios, music boxes or noise making devices into the gym. No Signs Are Allowed.
3. All Orange County coaches will rate both JV and varsity officials online or through their Athletic Director by means of returning a completed missing ratings sheet to the Athletic Coordinator within two weeks.
4. **Unsportsmanlike Conduct Rule**

Sportsmanship: The NYSPHSAA and Section IX recognizes and appreciates that the influence and responsibility of the school administration with regard to good sportsmanship extends to all levels of competition. However, it must also be seen that the NYSPHSAA AND Section IX has been vested with the responsibility to ensure that all contests under its jurisdiction are conducted satisfactorily. This standard applies to all regular season and post schedule play.

- I. **Coach (There is no appeal to a coach ejection. The official's decision is final). (Please refer to the NYSPHSAA Handbook – Sportsmanship; Standard 27b):**
 1. Any coach excluded by a certified official from an interschool competition for unsportsmanlike conduct is ineligible to coach any interschool competition in that sport until after the next previously scheduled contest at the same level (e.g. junior varsity, varsity, etc.) has been completed. **The coach may not be present at the game site.**

NOTE: “Not being physically present at the site” means the disqualified coach is not to be present in the locker room, on the sidelines, in the stands or site area before, during or after the game/meet.

2. A coach who strikes, shoves, kicks or makes other physical contact with the intent to do so to another person (e.g. official, another coach, player, fan) shall be expelled immediately and banned from further participation or coaching in all sports for one year from the date of the offense.
3. The coach that was ejected will notify his/her Athletic Director of the incident on the same day that it occurred. The Athletic Director will then contact the League Coordinator as the coach(s) will not be allowed to participate in the school’s next scheduled game/games as above.

II. Player Ejections: **(There is no appeal to a player ejection. The official’s decision is final).**

1. Any member of a squad ruled out of a contest for unsportsmanlike conduct (flagrant foul, two technical fouls in basketball, two yellow cards, red card, inappropriate language or taunting, fighting, etc.), the following action is **required** by the NYSPHSAA Regulations detailed in Standard #27b:
 - A. First Ejection – that player(s) cannot attend or participate in the next scheduled contest **in that sport**. If the season has ended the player(s) cannot attend or participate in the next scheduled contest in his/her next season of participation.
 - B. Second Ejection – that player(s) cannot attend or participate in the next two scheduled contests **in that sport**. If the season has ended the player(s) cannot attend or participate in the next two scheduled contests in his/her next season of participation.
 - C. Third Ejection – that player(s) cannot attend or participate in any remaining scheduled contests for the remainder of that sports season – including sectional, regional and state contests. If the season has ended the player(s) cannot attend or participate in the next three scheduled contests in his/her next season of participation.

***Please note: Disqualifications from one season will carry over to the next season of participation.**

2. Any member of the squad who strikes, shoves, kicks or makes other physical contact with the intent to do so to an official shall be expelled from the game immediately and banned from further participation in all sports for one year from the date of the offense. **NOTE:** “Member of the squad” includes player, manager, scorekeeper, timers, and statisticians.
3. Communication Responsibilities regarding ejections:
The coach of the player(s) who was/were ejected will notify his/her Athletic Administrator by 12 noon the following day. The Athletic Administrator **must** report the ejection to their respective League Coordinator by 12 noon the following day.

III. Official:

1. Unprofessional conduct on the part of official such as, but not limited to, taunting, baiting, use of profanity, shall be reported by a school administrator from the aggrieved school to the Section Executive Director. A request will be made to the appropriate sport officials' chapter to investigate the incident and to report their action to the Section in a timely manner.
2. The official who ejected the player(s) or coach shall notify the League Coordinator prior to 12:00 Noon the following day of the name(s) of the player(s) or the coach and the infraction(s). The League Coordinator shall notify the Athletic Director of the offending school.

5. Championships

- a. The OCIAA Girls Basketball League will consist of divisions.
- b. Each division will recognize a champion based on win/lose record within their division play.
- c. If there is a tie based on division records, the following will be used to determine that division champion:
 1. Head to Head overall for current season between teams that are tied.
 2. Points allowed between tied teams
 3. Record vs. the team occupying the next highest position in division standings
 4. Points allowed vs. the team occupying the next highest position in division standings

6. AWARDS (Varsity Only):

Plaques: 6 Division Champions (Team)

OCIAA Patches: Each individual school may purchase their own patches should they choose to do so.
