

**ORANGE COUNTY INTERSCHOLASTIC
ATHLETIC ASSOCIATION
JV/VARSITY BASEBALL BY-LAWS
Updated 3/19/2019**

1. The current National Federation of State High School Association Baseball Rules, NYSPHSAA Rules & Regulations and the following OCIAA adopted modifications will apply.
 - a. A game-ending procedure was approved in high school baseball. The run rule states that the game will end with a run differential of 10 runs after 5 innings (or 4 ½ if the home team is winning).
 - b. The 6:00 p.m. curfew rule would prevail IF there was a local school rule designating this fact. The local rule would be that no inning may start after 6:00 p.m., regardless if the varsity game is or is not in sight of the JV contest.
2. The official OCIAA baseball for varsity level play shall be the Spalding Pro Series (Item 41-100HS) or the Rawlings R100 during the regular season. The Spalding Pro Series (Item 41-100HS) **must** be used beginning with Sectional play. At the JV level, any baseball that meets NFHS requirements and has the NFHS Authenticating Mark on the ball can be used. Effective January 1, 2020, balls shall meet the NOCSAE standard at the time of manufacture and the NOCSAE mark will be required on all balls. The home school is responsible for three (3) new baseballs. Weather conditions may necessitate the need for additional baseballs.

3. **Unsportsmanlike Conduct Rule**

Sportsmanship: The NYSPHSAA and Section IX recognizes and appreciates that the influence and responsibility of the school administration with regard to good sportsmanship extends to all levels of competition. However, it must also be seen that the NYSPHSAA AND Section IX has been vested with the responsibility to ensure that all contests under its jurisdiction are conducted satisfactorily. This standard applies to all regular season and post schedule play.

I. Coach (There is no appeal to a coach ejection. The official's decision is final). (Please refer to the NYSPHSAA Handbook – Sportsmanship; Standard 27b):

1. Any coach excluded by a certified official from an interschool competition for unsportsmanlike conduct is ineligible to coach any interschool competition in that sport until after the next previously scheduled contest at the same level (e.g. junior varsity, varsity, etc.) has been completed. **The coach may not be present at the game site.**
NOTE: "Not being physically present at the site" means the disqualified coach is not to be present in the locker room, on the sidelines, in the stands or site area before, during or after the game/meet.
2. A coach who strikes, shoves, kicks or makes other physical contact with the intent to do so to another person (e.g. official, another coach, player, fan) shall be expelled immediately and banned from further participation or coaching in all sports for one year from the date of the offense.
3. The coach that was ejected will notify his/her Athletic Director of the incident on the same day that it occurred. The Athletic Director will then contact the League Coordinator as the coach(s) will not be allowed to participate in the school's next scheduled game/games as above.

II. Player Ejections: (There is no appeal to a player ejection. The official's decision is final).

1. Any member of a squad ruled out of a contest for unsportsmanlike conduct (flagrant foul, two technical fouls in basketball, two yellow cards, red card, inappropriate language or taunting, fighting, etc.), the following action is **required** by the NYSPHSAA Regulations detailed in Standard #27b:

A. First Ejection – that player(s) cannot attend or participate in the next scheduled contest **in that sport**. If the season has ended the player(s) cannot attend or participate in the next scheduled contest in his/her next season of participation.

B. Second Ejection – that player(s) cannot attend or participate in the next two scheduled contests **in that sport**. If the season has ended the player(s) cannot attend or participate in the next two scheduled contests in his/her next season of participation.

C. Third Ejection – that player(s) cannot attend or participate in any remaining scheduled contests for the remainder of that sports season – including sectional, regional and state contests. If the season has ended the player(s) cannot attend or participate in the next three scheduled contests in his/her next season of participation.

***Please note: Disqualifications from one season will carry over to the next season of participation.**

2. Any member of the squad who strikes, shoves, kicks or makes other physical contact with the intent to do so to an official shall be expelled from the game immediately and banned from further participation in all sports for one year from the date of the offense. **NOTE:** "Member of the squad" includes player, manager, scorekeeper, timers, and statisticians.

3. Communication Responsibilities regarding ejections:

A. The coach of the player(s) who was/were ejected will notify his/her Athletic Administrator by 12 noon the following day. The Athletic Administrator must report the ejection to their respective League Coordinator by 12 noon the following day.

III. Official:

1. Unprofessional conduct on the part of official such as, but not limited to, taunting, baiting, use of profanity, shall be reported by a school administrator from the aggrieved school to the Section Executive Director. A request will be made to the appropriate sport officials' chapter to investigate the incident and to report their action to the Section in a timely manner.

2. The official who ejected the player(s) or coach shall notify the League Coordinator prior to 12:00 Noon the following day of the name(s) of the player(s) or the coach and the infraction(s). The League Coordinator shall notify the Athletic Director of the offending school.

5. Baseball Umpires:

- a. Will be assigned by the Athletic Coordinator, which includes all league, non-league and scrimmages games.
- b. All JV and Varsity coaches will rate officials for all league and non-league games. Coaches are encouraged to sign up for online access for the ability to rate officials online.

6. Pre-game Procedure:

- a. 3:25 p.m. till 3:40 p.m., home team has field for warm-up.
- b. 3:40 p.m. till 3:55 p.m., visiting team has field for warm-up.
- c. 3:55 p.m., group rules
- d. 4:00 p.m., play ball
- e. Visiting team may have batting practice if there are two (2) batting areas.
- f. If the visiting team arrives late, an adequate warm-up of no less than 15 minutes will be allowed. The home team should already have warmed-up and be ready to play.

7. Championships:

- a. The OCIAA Baseball League will consist of divisions. There will be a champion in each division based on win/lose record within division play. In case of a suspended game the contest will be played out for all Division and AA crossover contests. If there is a tie based on division record, the following will be used to determine that division champion:
 - 1. Head to Head overall for current season between teams that are tied.
 - 2. Runs allowed between tied teams
 - 3. Record vs. the team occupying the next highest position in division standings
 - 4. Runs allowed vs. the team occupying the next highest position in division standings

8. Awards (Varsity only):

- a. Plaques: 6 Division
- b. OCIAA Patches: Each individual school may purchase their own patches if they choose to do so.

9. Schedules:

- a. Will be developed by the Athletic Coordinator.
- b. Each Varsity and Junior Varsity team may not schedule more than the approved maximum contests.
